The guidelines are set as follows:

Handling: onsite & offsite **Motor & Hydraulic Oils** handling performances

Storage: onsite & offsite **Motor & Hydraulic Oils** temporary or permanent storage

Transportation: transit or discharge **Motor & Hydraulic Oils** transportation

Tracking & recording: Supporting documentation **Motor & Hydraulic Oils** tracking & records

Treatment: Reclamation (Preparation For Reuse) **Motor & Hydraulic Oils** treatment method

Discharge or disposal: After sale (renewable energy) **Motor & Hydraulic Oils** Discharge & Disposal

All major producers have been allocated and defined to where Industrial Sector rated Category “I 1 – I 2” must undergo an environmental audit to where Categories “I 3 – I 4 – I 5” along all other **Motor & Hydraulic Oils producing** commercial entities shall produce reports based on inspections and surveys in addition to supporting documentations.

In compliance with the conditions incorporated with **Endorsement Certificate** and as a submission to such conditions please note the following commended services and subservices to be provided by Boosters SAL. and its subsidies, as well supported by official documentations, will furnish to the **Used Motor & Hydraulic Oils Waste** producers an "Environmental Compliance Certificate" valid through 31-12-2020. (this date is set by the ministry of environment to where conditions may be modified or changed).

- a.2** onsite and offsite storage conditions – Human Safety & Electrical & Fire Hazards
- a.3** onsite offsite – drainage & sewer systems conditions and cleanliness
- a.4.** onsite offsite – Tracking and recording – Contracts supporting documents etc.

The survey & inspection service can be provided independently by Boosters SAL. subsidized establishment Drain Doctor – (affordable tenderer) on the expense of the producer of the **Used Motor & Hydraulic Oils Waste**. Drain Doctor will issue an official report to Boosters SAL. and a Compliance Certificate valid through 31-12-2020 will be accordingly issued.

b) Collection & Transportation:

- b.1** Collector & Transporter – The party collecting and transporting
- b.2** Tracking & Recording – The party issuing the tracking & recording documents
- b.3** Fees and expenses – Transportation shall be deemed by transporting party
- b.4.** Liability & Insurance – Shall be provided by collecting & Transporting party
- b.5** Routing & Scheduling – Shall be implemented for adequate service performance & cost

Boosters SAL. will provide an **official tracking and record voucher** for the quantity collected by its collectors and shall assume all **incorporated fees and expenses**. Boosters SAL. will maintain an **adequate schedule and routing procedure** that benefit all parties. Assigned & Designated Collectors and Transporters by Boosters SAL. **shall comply with all set arrangements between Boosters SAL and the producing Party** and shall present **official and valid identification** as well all supporting documents and furnish **official waste tracking records**.

c) **Reclamation & Treatment “Preparation For Reuse”**

- c.1 Receiving and storage – Source and quantity verification storage admission & recording
- c.2 First phase treatment – Dewatering and sediment gravity
- c.3 Second & Third Phase Treatment – Differential pressure filtration (Contained Filter Trap)
- c.4. Fourth Phase – Vacuum extraction (Electrical Heat Extraction Zero Emission)
- c.5 Fifth Phase – Differential pressure Polishing (Contained Earth Bleaching Media)

Boosters SAL. under its **Environmental Conditional Endorsement Certificate** shall execute the entire treatment process of the **Used Motor & Hydraulic Oils Waste** before discharging. All oil wastes collected by Boosters SAL. within the **“validated pre-agreed arrangements with the producer”** and shall be treated solely at the expense of Boosters SAL.

Any producing party desiring to treat its Oil Waste will be charged a uniform fee according to the quantity treated as follows:

05 to 10 barrels: “45,000 LBP Per Barrel” Transportation excluded (Free Of Charge Storage 24 Hours)

11 to 30 barrels: “37,500 LBP Per Barrel” Transportation excluded (Free Of Charge Storage 48 Hours)

31 to 60 barrels: “32,000 LBP Per Barrel” Transportation excluded (Free Of Charge Storage 72 Hours)

61 + Barrels : “30,000 LBP Per Barrel” Transportation excluded (Free Of Charge Storage 72 Hours)

Transportation charges shall be 3,000 LBP per barrel within 30 KM from Beirut and 5,000 LBP within 50 KM from Beirut. Remote Areas and greater than 50 KM distances shall be calculated according to volume and location. (This service is subjected to the approval of Boosters SAL. and shall not be considered obligatory).

Treated volume will be subjected to 5% volume loss. Barrel shall be calculated at 200 liters. Additional Storage charges of 1,000 LBP per barrel for each 24 hours shall be implemented after treatment. No charges shall be implemented for pre-treatment storage.

N.B.: **Official Treatment Documentation Certificates** will be issued only for the exact quantity and addressed to the main producer. (no documentations issuance shall be addressed to third parties.

d) **Discharge – Disposal & After Sale**

d.1 Disposal – Executed at the discretion of Boosters SAL. (Environmental Compliance)

d.2 Discharge – Executed at the discretion of Boosters SAL. (Environmental Compliance)

d.3 After Sale– Executed at the discretion of Boosters SAL. (End User Official Documentations)

Boosters SAL. shall environmentally comply in all **post treatment activities** in accordance the **environmental regulations** and shall be submitted to the proper department at discretion the **Ministry of Environment**.

All activities shall be officially documented and recorded and in compliance with the “**Ministry Of Finance Guidelines**”. All financial transactions are subjected to appropriate **Tax Laws** and submitted accordingly.

All monetary transactions shall be conducted in **Lebanese Pounds as of October 15th, 2019**.

Boosters SAL. will honor all pre-arranged agreement with the producers as set in writing as of **October 15th, 2019** and through **December 12th, 2020**.

N.B.: Boosters SAL. is available to initiate a pre-arranged agreement with present and future producers and will assume all obligations and responsibilities on behalf of the producers and in accordance to the set forth agreement.

We hope our services will serve equally the benefit of our environment as well as all parties institutional financial deeds.
